## *Residential Permit Parking*

### **RULES AND REGULATIONS**

Pursuant to his authority as Director of Public Safety, the Mayor of the City of Bexley hereby adopts and establishes the following rules and regulations governing the issuance and use of residential parking permits.

1. Permits may be obtained, by qualified residents, at the Bexley Police Department, 2242 East Main Street. The Bexley Police Department is open 24 hours a day, 7 days a week. The fee for residential parking permits is \$1.00 per permit. The fee is assessed annually.
2. Residents qualified for residential parking permits are those residents who live on streets where permit parking has been approved by the Safety Director and City Council.
3. Parking permits are to be displayed on the ***left rear bumper*** of the vehicle. Vehicles parked in permit only parking areas not displaying a parking permit, issued by the City of Bexley, are subject to citation and may be towed. ***Parking permits must be displayed*** in order to avoid citations.
4. Parking permit applications require the name of the resident of the property for which the permit is being issued, the address of the property, the make, model, color, vehicle identification number, and license plate number of each motor vehicle parked at that residence.
5. Proof of residency must be provided at the time of application. Proof of residency may be any of the following: Motor vehicle registration, valid Ohio driver's license, rent/mortgage payment receipt, or other documentation indicating the address of the residence for which the permit is requested.
6. Parking permits issued by the City of Bexley remain the property of the City of Bexley.
7. Parking permits issued by the City of Bexley are non-transferable, i.e.; they are only valid when displayed on the vehicle for which they were issued.
8. Residential parking permits must be renewed in January of each calendar year. New permits (for the current calendar year) must be properly displayed no later than February 1<sup>st</sup> of each calendar year.
9. Damaged or lost parking permits may be replaced for \$1.00. A police report must be completed.

10. Parking permits are valid only within the immediate area of the residence for which they are issued, i.e.; on the street of residence and within that block. Parking permits are not intended for, nor are they valid, in any other area of the city.
11. Parking permits are intended only for the use of the resident to whom they are issued. Misuse of parking permits may result in revocation of the permit and prosecution under Bexley Ordinance 56-94.
12. **There is a limit of three (3) residential parking permits per household.**
13. Visitors do not need a permit unless they are staying for more than seven days. Residential parking approval for visits of less than 7 days only requires notification to the Mayor's Office.
14. Residential parking permit holders are required to comply with all other parking restrictions, e.g.; 24 hour parking limit, parking within 5 feet of a driveway, or parking within 10 feet of a fire hydrant.
15. If a permit holder sells or otherwise changes vehicles during the year a new permit may be obtained at no cost. The free replacement permit will be provided only once per calendar year for permit holders. Any additional permit changes will be made at the normal \$1.00 per permit rate. The old permit will be invalidated when the replacement permit is issued.
